

Panamera Invitational Tournament ("Tournament")
Official Rules

NO PURCHASE OR PAYMENT NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT WILL NOT IMPROVE YOUR CHANCES OF WINNING. ALL FEDERAL, STATE, LOCAL, AND MUNICIPAL LAWS AND REGULATIONS APPLY. VOID WHERE PROHIBITED.

1. Sponsor

Porsche Cars North America, Inc., 1 Porsche Drive, Atlanta, Georgia USA 30354 ("Sponsor")

2. Eligibility

The Panamera Invitational Tournament is open to persons who are twenty-five (25) years of age and older as of June 11, 2021. Only U.S. residents are eligible to enter the Tournament. Employees, officers, and directors of Sponsor or Topgolf Media LLC and their parents, subsidiaries, affiliates, distributors, sales representatives, advertising and promotional agencies, any other persons or entities involved in the development and/or administration of the Tournament (collectively, "Tournament Entities"), and the immediate family members (parent, child, sibling, or spouse/partner) and/or household members (whether or not related) of such Tournament Entities are not eligible to participate in the Tournament. Active or retired professional golfers on any professional golf tours, including but not limited to the PGA Tour, LPGA, Web.com, PGA TOUR Canada, PGA TOUR Latinoamérica, PGA TOUR China, and Symetra Tour, are not eligible to participate in the Tournament, unless Sponsor has granted a waiver in writing. To enter the Tournament and/or receive a prize, you must fully comply with these Official Rules, and by participating in the Tournament, you agree to abide by and be bound by these Official Rules and the decisions of Sponsor and its designees, whose decisions shall be binding and final in all respects relating to the Tournament.

3. Tournament Period

The Tournament begins at 09:00am EDT on June 11, 2021 and ends at 9:00pm EDT on August 6, 2021 ("Tournament Period"). Eastern Time shall control for all purposes of this Tournament. Sponsor's clock shall be the official time-keeping device for all purposes of this Tournament.

4. How to Enter/Participate

Online Registration: General registration for the Tournament commences at 12:00 AM EDT on June 11, 2021. Registration is Venue (defined below) based, and each Venue will accept up to sixty-eight (68) Teams of two people that can participate in the Local Tournament (defined below) at that Venue, provided all of the Participants (defined below) meet the eligibility requirements of these Official Rules and register in the manner and within the timeframe specified herein. The deadline for registration for each Venue is listed below. **Registration is on a first-come, first-served basis and will end the earlier of: (i) when all sixty-eight (68) Teams have registered for a specific Venue; or (ii) the applicable deadline listed below.** A Venue specific Team wait list will be accepted for each Venue once sixty-eight (68) Teams have registered for that particular Venue. Registrants on the wait list will be notified via email in the event a Team spot opens at the selected Venue, and registrants will have twenty-four (24) hours from the time the email is sent to complete the Tournament registration process. If a registrant does not

complete the registration process within that twenty-four (24) hour period, then she/he/they will forfeit his/her/their right to register, and the next person on the wait list will be notified. All registrations must be completed prior to the applicable Local Tournament. **Each participant can register for and participate in the Tournament at one (1) Venue only.**

Each Team participant must complete an Online Registration for the Tournament. Each team member ("Participant"), as part of the process to register for the Tournament, must do the following: (i) visit <http://panamerainvitational.com> or <https://na.eventscLOUD.com/website/26343/> and provide the names of both Participants (who must both be eligible, as per the Official Rules, to participate in Tournament); (ii) select a Local Tournament Venue; (iii) complete the registration form in its entirety; (iv) agree to all of the terms and conditions of the Official Rules; and (v) certify that the Participant is not an active or retired professional golfer on a professional golf tour at the time of registration and will not be throughout the Tournament. Only fully-completed registration forms are eligible for participation in the Tournament. Within twenty-four (24) from the time of registration, a Participant will receive an email containing information about the Tournament, including a link to the Tournament Official Rules. A Participant may change his/her/their selected Team member up until the time of onsite registration on the day of applicable Local Tournament, so long as there is a completed registration for both Team members. If a Participant's original selected Team member has already started the onsite registration, then Participant will no longer be able to change his/her/their selected Team member.

The following are the dates and Venue locations for the Local Tournaments. All Local Tournaments will take place between 8:00AM – 1:00PM local time of the Venue.

5. Tournament Overview

This Tournament consists of fifteen (15) "Local Tournaments" and one (1) "Finals". The Local Tournaments and the Finals will collectively be referred to herein as the "Tournament." Participants participate in the Tournament as part of a team of two (2) individuals, and that Team is determined at the time of registration for the Tournament (each a "Team" and collectively "Teams"). Each Team member must meet the eligibility requirements stated in the Official Rules. All match plays are judged by Team score by Sponsor, whose decisions are final and binding. Sponsor assumes no responsibility for, and will not resolve, any disputes among Team members with regard to any aspect of the Tournament. In the event that any such disputes interfere with the operation of the Tournament, the applicable Team(s), including both members of Team(s), may be disqualified from the Tournament, in

Sponsor's absolute and sole discretion. The winners of the Local Tournaments will be the Team at each Venue (defined above) with the highest Team score (as further described in Section 6 herein). The winners of the Finals will be the Team with the highest Team score of the Finals.

The Local Tournaments will take place on the dates and at the locations listed above in Section 4 (each a "Venue" and collectively "Venues"). Up to sixty-eight (68) Teams may participate in the Local Tournament at each Venue. The Team with the highest Team Score in the Local Tournament for each Venue will be determined to be the "Local Champions" for that Venue. Each Local Champion Team will be eligible to compete in the Finals (pending verification and compliance with the Official Rules).

The Finals are scheduled to take place in Las Vegas, Nevada on August 7, 2021. All participants must be prepared to travel to the Finals if they are determined to be a Local Champion. Dates are subject to change in Sponsor's sole discretion. If a potential Local Champion is not available to travel on the dates specified by Sponsor, or for any other reason cannot or will not attend the Finals, Local Champion privileges will be terminated for that Local Champion Team and, if time permits, an alternate Local Champion Team next in contention for Local Champion designation from that Venue will be determined to be the Local Champions for that Venue (pending verification and compliance with these Official Rules). For the Finals, any individual member of a Team that is not a legal resident of the United States must demonstrate status such that the individual has the right to participate in the Finals in Las Vegas, Nevada.

6. Game Play

Local Tournaments and Finals:

Schedule for day of Local Tournaments (all times below are Venue-specific local time):

8:00 AM: Venue opens

8:00 AM – 9:00 AM: Registration/Breakfast

8:00 AM: Practice opens (NOTE: all Teams MUST check in by 8:45 AM)

8:45 AM – 9:00 AM: Mandatory rules meeting

9:00 AM: Tournament begins

9:00 AM – 11:00 AM- All Teams to play TopContender. During the time of competition, the Team with the highest cumulative game score at each Venue moves on to the participate in the Finals in Las Vegas.

11:00AM – 12:00PM – Tournament Wrap-Up

11:30AM – Lunch Served

12:00PM – 1:00PM – Awards & Networking – No Gameplay

1:00 PM – Projected finish

Note – All Tournament hitting bay assignments will be determined in a random manner prior to commencement of match play.

Ties

In the event of a tie during any Local Tournament or at the Finals, Sponsor will determine a match of game play, and the Team with the highest Team score from that match will be determined to be Winners of that Local Tournament or Finals.

Both members of each Team must check in by 8:45 AM local time the morning of the applicable Local Tournament. If both Team members are not present at this time, Sponsor reserves the right to advance a Team on the wait list to play in the applicable Local Tournament, and no refund of registration fee will be provided to the disqualified Team.

All Participants are required to bring a valid, government-issued photo identification to the Local Tournament (and Finals if determined to be a Local Champion).

All Participants must hit their shots in the order directed by the game type. Any Participants caught hitting out of order will be eliminated from the Tournament.

Only the Tournament-designed Bay Auditor is allowed to make ball/score edits to the screen. All ball/score edits must be made prior to the next shot. Any edits that are requested once another ball has been hit will be denied.

All four (4) Participants playing in a bay will attempt to agree to the change in score in order for the ball/score edit to be made by the Bay Auditor. If the four (4) Participants cannot reach an agreement, the Bay Auditor will make the final decision.

Any Participant making ball/score edits on his/her/their game panel will be eliminated from the Tournament.

All games must take place during the designated time of competition. Teams will be notified at the following time markers of how much game time is remaining:

- a. 15 minutes
- b. 10 minutes
- c. 5 minutes
- d. 2 minutes

All balls not played prior to the time limit expiring will be recorded as zeros.

The Tournament will not allow any use by Participants of technology devices, including but not limited to rangefinders or electronic measuring devices. Any such use by a Participant will be cause for immediate elimination from the competition of that Participant's Team.

Anyone behaving in a disorderly or disruptive manner, breaking or attempting to break the game play rules, cheating or attempting to cheat, or delaying, attempting to delay, or otherwise participating at an unnecessarily slow pace, may be asked to leave the Venue premises and be disqualified from the Tournament, as determined by Sponsor in its sole discretion.

Dress Code: Participants can wear any clothes or shoes that he/she/they feels comfortable wearing while participating in Tournament; however, clothing must not feature famous characters, brand names or logos, or otherwise display copyrighted or trademarked materials or properties. Clothing also must not feature vulgar, obscene or otherwise offensive or insensitive words or images, as determined by Sponsor in its sole discretion.

7. Entry Guidelines

LIMIT ONE ENTRY PER PERSON, REGARDLESS OF VENUE. Submission of multiple entries by or on behalf of the same person will result in ineligibility with respect to all entries submitted by or on behalf of that person. Entries must be submitted by the entrant. Once submitted, entries cannot be deleted, canceled, or modified. All entries must be received during the Tournament Period, as defined above. Incomplete and/or incorrect entries will be voided and ineligible for a prize. Proof of sending or submission will not be deemed to be proof of receipt by Sponsor. Normal Internet access, phone, and usage charges imposed by your Internet and/or phone service(s) may apply. All entries become the property of Sponsor when submitted and will not be acknowledged or returned to entrant.

Entries submitted in connection with this Tournament will be reviewed to ensure compliance with these Official Rules. Sponsor and its designees shall have the sole right to reject or remove an entry at any time.

8. Representations and Warranties/Indemnification

Each person or Participant who enters this Tournament represents and warrants that she/he/they will abide by and comply with these Official Rules. Each person or Participant further represents and warrants that the entry she/he/they submits does not contain any material that would defame or otherwise violate or infringe upon the rights of any third party, including patents, copyrights, trademarks, or rights of privacy or publicity, and will not violate any federal, state, or local laws or ordinances. Each entrant or Participant hereby agrees to indemnify and hold harmless Tournament Entities from and against any and all third-party claims, actions, or proceedings of any kind and from any and all damages, liabilities, costs, and expenses relating to or arising out of any breach or alleged breach of any of the warranties, representations, or agreements of entrant hereunder.

9. Prizes

One (1) Team of two (2) members ("Winners") will be selected from each Local Tournament for a total of thirty (30) Winners (fifteen (15) teams each consisting of two (2) members) based on scoring criteria defined by Sponsor. Winners will receive a trip inclusive of airfare travel and hotel to Las Vegas, Nevada to compete in the Tournament Finals, currently scheduled for August 7, 2021. Each individual Winner must confirm his/her/their acceptance of a Prize via email or written confirmation to Sponsor or its designee between June 26, 2021 and July 24, 2021 or that Winner shall forfeit his/her/their Prize. Approximate Retail Value ("ARV") of each Prize: \$2,100; however, ARV may vary based on point of departure, travel dates, and fare/rate fluctuations. If a Winner resides within a two hundred (200) mile

radius of Las Vegas, Nevada, airfare travel will not be provided, and no compensation will be awarded in lieu of the difference in the ARV of the Prize.

One (1) Team of two (2) members ("Grand Prize Winners") will be selected from the Tournament Finals in Las Vegas, Nevada based on scoring criteria defined by Sponsor to receive a "Grand Prize" trip on the Porsche Golf Circle St. Andrews / Scotland Program for each Team member and a guest 18 years or older as of October 20, 2021 that includes airfare, hotel, meals, ground transportation, entertainment and green fees. Each individual Grand Prize Winner must confirm his/her/their acceptance of a Grand Prize via email or written communication between August 7, 2021 and August 21, 2021, or that Grand Prize Winner shall forfeit his/her/their Grand Prize. As part of the Grand Prize, each Grand Prize Winner must meet the minimum Handicap Index requirement of 24 for men and 36 for women to play the Old Course and Kingsbarns Golf Links. In the event that the minimum Handicap Index requirement is not met by either of the two (2) Grand Prize Winners, the Sponsor will provide a comparable Porsche experience available through the Porsche Golf Circle St. Andrews / Scotland Program. Acceptance of the Grand Prize by both Grand Prize Winners is not required for the Grand Prize to be provided to either member of the Grand Prize Winning team of (2). Approximate Retail Value (ARV) of the Grand Prize: \$30,000; however, ARV may vary based on point of departure, travel dates, and fare/rate fluctuations.

Total ARV of all Prizes and Grand Prizes: \$64,200

Travel arrangements shall be through Sponsor's designated agent on a carrier of Sponsor's choice. Certain restrictions apply, and travel is subject to applicable provider's terms and conditions. Prizes and Grand Prizes may not be combined with any other offer, and travel may not qualify for frequent flyer miles or other similar credits or benefits.

The travel companion of each Grand Prize Winner must travel with Grand Prize Winner on the same itinerary and shall be required to sign and return a travel companion release and release of liability/publicity prior to issuance of travel documents.

Each Winner, Grand Prize Winner, and travel companion of Grand Prize Winner is solely responsible for securing passports, visas, and any other required travel documents before the date of travel. If travel documents cannot be secured before the date of travel, that Winner or Grand Prize Winner forfeits his/her/their prize, and a replacement prize and/or cash will not be awarded.

Prizes and Grand Prizes may not be sold, auctioned, offered for sale, assigned, transferred, offered for transfer, photocopied, duplicated, or redeemed or exchanged for cash, merchandise, or services, except by Sponsor, in its sole and absolute discretion, who reserves the right to substitute Prize or Grand Prize with a prize of comparable or greater value if Prize or Grand Prize becomes unavailable.

Each Winner and Grand Prize Winner is solely responsible for all other expenses not specifically mentioned herein, including but not limited to federal, state, and local taxes, meals, and ground transportation, regardless of whether Prize or Grand Prize is used in whole or in part. Each Winner and Grand Prize Winner shall be issued an IRS Form 1099 for the retail value of the Prize/Grand Prize and is advised to seek independent counsel regarding the tax implications of prize winnings. Each Winner and

Grand Prize Winner shall be required to sign an Affidavit in connection with acceptance of a Prize or Grand Prize.

10. Odds

Odds of winning a Prize or Grand Prize depend on the number of eligible entries received and the number of Participants.

11. Selection of Winners and Grand Prize Winners

Winners and Grand Prize Winners will be selected based on scoring results from participation in the Tournament gameplay as described in detail in these Official Rules.

12. Winner Notification/How to Claim Prizes/Grand Prizes

Between June 26, 2021 and July 24, 2021, Sponsor or its representatives will attempt to notify the potential winners of their potential winning status, including the possible advancement to the Tournament Final scheduled for August 7, 2021. On or around August 7, 2021, Sponsor or its representatives will attempt to notify the potential Grand Prize winners of their potential winning status. If the potential winners do not meet eligibility criteria or are otherwise unwilling or unable to comply with these Official Rules, or cannot be contacted successfully, potential winners may be deemed, in Sponsor's sole discretion, to have forfeited a Prize or Grand Prize, and alternate potential winners may be selected. Those who do not win will not be contacted.

13. Publicity

Except where and as may be prohibited by law, participation in the Tournament and/or acceptance of a prize constitutes express permission of each Participant and/or winner for Sponsor, Topgolf Media LLC, and those acting pursuant to the authority of Sponsor and Topgolf Media LLC to use such Participant's and/or winner's entry, name, photograph, image, likeness, voice, opinions, city, state, and country of residence for advertising, trade, promotion, and publicity purposes in all forms of media now known or hereafter discovered or devised, worldwide in perpetuity, without further notice, review or approval, or compensation.

14. General Conditions

This Tournament is subject to all applicable international, federal, state, and local laws and regulations. Tournament Entities are not responsible for incorrect or inaccurate entry information, whether caused by any of the equipment or programming associated with or utilized in the Tournament, or by any technical or human error, which may occur in the processing of the Tournament entries. Tournament Entities are not responsible for interrupted or unavailable network server or other connections, miscommunications, failed telephone or computer transmissions or jumbled, scrambled, or misdirected entries or transmissions, or for phone, electrical, network, computer hardware or software or program malfunctions, failures or difficulties or for other errors, omissions, interruptions, or deletions of any kind whether human, mechanical, or electronic or for any damage to any person's computer, phone, tablet, or other device related to participating in the Tournament. By participating in this Tournament, entrants waive any right to claim ambiguity in these Official Rules.

Tournament Entities are not responsible if Tournament cannot take place or if any Prize or Grand Prize cannot be awarded due to delays, interruptions or failures due to acts of God, war, natural disasters, weather, acts or threats of terrorism, strikes, lockouts, labor disputes, pandemics, work stoppages, fire, acts of government, or other events outside of the reasonable control of Tournament Entities. If, for any reason the Tournament is not capable of running as planned, including, without limitation, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, or any other causes beyond the reasonable control of Tournament Entities, which, in Sponsor's sole determination, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Tournament, Sponsor reserves the right, in its sole discretion, to cancel, terminate, modify, or suspend the Tournament or any part of the Tournament. If the Tournament or any part of the Tournament is terminated or modified prior to the end date of the Tournament, notice will be posted on <http://panamerainvitational.com>, and Sponsor will use its best efforts to reschedule the complete Tournament, or remaining elements of the Tournament at a later date. Sponsor reserves the right, in its sole and absolute discretion, to modify and amend these Official Rules from time to time during the Tournament for clarification purposes. Failure by Sponsor to enforce any term of these Official Rules shall not constitute a waiver of that provision.

CAUTION: ANY ATTEMPT TO DELIBERATELY DAMAGE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS TOURNAMENT IS A VIOLATION OF CRIMINAL AND CIVIL LAWS. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES OR OTHER REMEDIES FROM ANY SUCH PERSON(S) RESPONSIBLE FOR THE ATTEMPT TO THE FULLEST EXTENT PERMITTED BY LAW. Sponsor reserves the right, in its sole discretion, to modify, cancel, or suspend this Tournament and award the Prizes and Grand Prizes in accordance with the winner selection process described above from among all eligible entries received as of such date should fraud, virus, bugs, or other causes beyond Sponsor's control corrupt the administration, fairness, proper play or security of the Tournament. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision. Sponsor reserves the right, in its sole discretion, to disqualify any individual it or its designees find to be attempting to tamper with or undermine the entry process, any website or social media account or page associated with this Tournament, and/or the legitimate operation of the Tournament; to violate the Official Rules; or to act in an unsportsmanlike or disruptive manner or with the intent to annoy, abuse, threaten, or harass any other person. Tournament Entities are not responsible for: (a) any incorrect or inaccurate information, whether caused by entrants, printing errors, or by any of the equipment or programming associated with or utilized in the Tournament; (b) technical failures of any kind, including, but not limited to malfunctions, interruptions, or disconnections in phone lines or network hardware or software; (c) unauthorized human intervention in any part of the entry process or the Tournament; (d) technical or human error that may occur in the administration of the Tournament or the processing of entries; or (e) any injury or damage to persons or property that may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Tournament or receipt, use, or misuse of any prize.

15. Limitations of Liability

By participating in this Tournament and/or accepting a prize, each Participant (for himself/herself and his/her/their heirs) agrees to release Tournament Entities from any and all liability whatsoever for any injuries, losses, illnesses, or damages of any kind caused by entering or participating in the Tournament or for damages of any kind caused by any prize or resulting from acceptance, possession, or use/misuse of any prize awarded. **IN NO EVENT WILL TOURNAMENT ENTITIES BE RESPONSIBLE OR LIABLE FOR ANY**

Any legal proceedings arising out of this Tournament or relating to these Official Rules shall be instituted only in the federal or state courts located in the State of Georgia, and all Tournament entrants and Participants consent to jurisdiction therein with respect to any legal proceedings or disputes of whatever nature arising under or relating to these Official Rules and/or this Tournament. The invalidity or unenforceability of any provision of these Official Rules shall not affect the validity or enforceability of any other provision. In the event that any provision is determined to be invalid or otherwise unenforceable or illegal, these Official Rules shall otherwise remain in effect and be construed in accordance with their terms as if the invalid or illegal provision were not contained herein.

17. Use of Data

Any personally-identifiable information collected during an entrant's or Participant's participation in this Tournament will be collected by Sponsor and used by Sponsor and its designees for purposes of the proper administration and fulfillment of this Tournament as described in these Official Rules. In addition, by entering and/or participating in this Tournament, entrants and Participants agree to Sponsor's use of his/her/their personal information as described in Sponsor's Privacy Notice, which is located at <http://www.porsche.com/usa/privacy-policy/>. Sponsor's Privacy Notice may be updated from time to time without notice. Sponsor may use entrants' and Participants' information to send marketing communications regarding promotional offers and product information.

18. Code of Conduct

Tournament Participants shall be expected to:

- a. Be considerate and respectful to all Tournament Participants, Sponsor, staff, and other persons involved in the Tournament
- b. Refrain from demeaning, discriminatory, or harassing behavior, materials, and speech

- c. Speak up if they observe anything at the Tournament that conflicts with this Code of Conduct. If you are being harassed or feel uncomfortable, notice that someone else is being harassed, or have any other concerns, please contact a member of the Tournament staff immediately.

Unacceptable Behavior

Unacceptable behavior from any Tournament Participant will not be tolerated. Unacceptable behavior includes, but is not limited to:

- a. Intimidating, harassing, abusive, discriminatory, derogatory, or demeaning speech, materials, or conduct by any Participant of the Tournament and related Tournament activities. Many Tournament venues are shared with members of the public; please be respectful to all patrons of these locations.
- b. Violence, threats of violence, or violent language directed against another person.
- c. Sexist, racist, homophobic, transphobic, or otherwise discriminatory jokes and language.
- d. Personal insults, particularly those related to gender, sexual orientation, race, religion, or disability.
- e. Inappropriate photography or recording.
- f. Taking of photos within the Tournament environment for use on social media, without the prior permission of the individuals or owners of the content therein.
- g. Any boisterous, lewd, or offensive behavior or language, including but not limited to using sexually explicit or offensive language, materials or conduct, or any language, behavior, or content that contains profanity, obscene gestures, or racial, religious, homophobic, transphobic, or ethnic slurs.
- h. Failure to obey any rules or regulations of the Tournament Venues.
- i. Firearms, weapons (including weapon replicas), ammunition, dangerous or hazardous devices or substances and illegal items are prohibited at all Tournament-related events.

Consequences of Unacceptable Behavior

Unacceptable behavior will not be tolerated. Anyone asked to stop unacceptable behavior is expected to comply immediately. If an entrant or Participant engages in unacceptable behavior, Tournament staff may take action it deems appropriate, including warning or expelling the offender from the Tournament. For more egregious behavior, the Tournament staff may, in its reasonable discretion, temporarily ban or permanently expel an entrant or Participant from the Tournament and/or Venue.

19. COVID-19 Policies and Practices

Sponsor will follow the guidance of local and state guidelines in response to COVID-19 safety protocols, including but not limited to any facemask requirements. Sponsor strongly encourages Participants to wear facemasks in all common areas of the Venues. Specific requirements by Venue can be found online at <https://topgolf.com/us/play-safely/facemask-req/>, which will updated as local and state requirements change. By participating in the Tournament, each entrant and Participant agrees to adhere to any requirements specific to the Venue and location in which the Tournament is taking place. In the event of non-compliance with any requirements by an entrant or Participant, Tournament staff may, in its sole discretion, temporarily ban or permanently expel an entrant or Participant from the Tournament and/or Venue.
