## TERMS AND CONDITIONS

**These Terms and Conditions apply to your participation in and/or registration for the 2022 Tandem | Transplantation & Cellular Therapy Meetings of ASTCT and CIBMTR, (also herein referred to as "event"), which are organized by the American Society for Transplantation and Cellular Therapy and the Center for International Blood and Marrow Transplant Research (collectively the "Show Organizer"). Please carefully review the following Registration Policies along with the Legal Disclosures and Attendee Release Agreement. You must agree to all of these policies and waivers within the registration process.**

### CANCELLATIONS and REFUNDS POLICY

Cancellations must be sent in writing by January 12, 2022, to [TandemRegistration@conferencedirect.com](mailto:TandemRegistration@conferencedirect.com). Your registration fee, less a \$75 administrative fee, will be refunded in the same form as the payment was made if cancellations are received by January 12, 2022. Registrations cancelled on or after January 13, 2022, will not be refunded. Any exceptions shall be at the sole discretion of Show Organizer.

### REGISTRATION TRANSFERABILITY

Registrations are transferable within your organization. Substitution requests must be sent in writing by January 12, 2022. Please email [TandemRegistration@conferencedirect.com](mailto:TandemRegistration@conferencedirect.com) to make these arrangements. After January 12, 2022, registration substitutions will not be accepted.

Attendees may transfer from a virtual attendee to an in-person attendee and from an in-person attendee to a virtual attendee. Please email [TandemRegistration@conferencedirect.com](mailto:TandemRegistration@conferencedirect.com) to make these arrangements. If attendees make one of these aforementioned registration transfers the attendee must pay any outstanding balance and complete any additional registration fields. After January 12, 2022, registration transfers from an in-person attendee to a virtual attendee will not receive refunds of the registration balance.

### WIRE TRANSFER and CHECK POLICY

**Wire transfers** must reference "Tandem Meetings" and include both your full name and registration confirmation number for accurate processing. To receive a specific conference rate, wire payments must be dated no later than the registration rate deadline or you will be charged the next registration rate and incur an additional balance. Therefore, if registered by December 14, 2021, payments by wire transfers must be dated no later than December 14, 2021, to receive the Early Registration Rate. If registering on or after December 15, 2021, when the Standard Registration Rates begin, note that all payments by wire transfer must be received by January 12, 2022.

If registering on or after December 15, 2021, when the Standard Registration Rates begin, note that checks must be received by January 12, 2022. There will be a \$15 fee for all returned checks.
