- **5. How to Enter:** During the Contest Period, register and attend the Tech Talks with Topgolf webinar and then play the Closest to the Pin 9-Hole Challenge game, hosted by World Golf Tour (your "Submission"). Your Submission must include you competing the Closest to the Pin 9-Hole Challenge game. Submissions must comply with the Guidelines and Restrictions defined below. This Contest is in no way sponsored, endorsed or administered by, or associated with World Golf Tour or Topgolf Entertainment Group (TEG).
- **6. Guidelines and Restrictions:** Each entrant may enter the Contest one (1) time during the Contest Period. Submissions received from any person or email address in excess of the stated limit will be void. Submissions generated by script, macro or other automated means are void.  - The five lowest scores will determine the winners, with first place being the lowest score.
