

# **Toastmasters 2024 International Convention**

**Terms & Conditions** 

The terms "us" or "we" refers to Toastmasters International ("Toastmasters International", "Toastmasters"). The terms "I", "my", "you" or "your" refers to the Convention Registrant. The term "Parties" refers to you and Toastmasters, collectively. The term "Event" refers to the Toastmasters International Convention.

The Terms and Conditions below govern you at the Event, including but not limited to the following: Executive Committee Meeting, Board of Directors Meeting, District Leader Training, World Championship of Public Speaking, Candidate Showcase, Annual Business Meeting, etc.

## PRIVACY POLICY

When registering for the Event, we collect personal information you voluntarily provide us, including your name, address, and other contact information. Your personal information is collected as necessary in accordance with our <a href="Privacy Policy">Privacy Policy</a> and other Data Protection Laws. We will never sell your information for any purpose.

For the purposes of registering for the Event, Data Protection Laws shall mean applicable local, national, and international laws, regulations, regulatory guidance and opinions, and sectoral recommendations, each as amended, relating to the privacy, security, protection, or Processing (as defined below) of Personal Data (as defined below). This includes, but is not limited to, the EU General Data Protection Regulation ("GDPR"), Colorado Privacy Act ("CPA"), California Consumer Privacy Act ("CCPA"), California Online Privacy Protection Act ("CalOPPA"), and any subsequent amendments and successor legislation thereto, along with any other applicable privacy, security, and data protection laws.

Toastmasters agrees to comply with all applicable Data Protection Laws in relation to the processing, privacy, and security of Personal Data under this registration. In the processing of Personal Data, we ensure the protection of the rights of the data subjects as provided for under the Data Protection Laws. We shall implement appropriate technical and organizational measures to ensure a level of security appropriate to the risk of processing Personal Data, in accordance with the requirements of the Data Protection Laws.

The completion of this registration is also subject to the following terms:

## NAME AND LIKENESS USE

By registering for and attending the Event, I consent, grant, and authorize Toastmasters its licensees, successors, and assigns, the right in perpetuity and throughout the universe, to capture photographs, video recording(s), and/or audio recording(s) (collectively the "Media") (including any voice that is audibly heard) of you at the Event. I grant Toastmasters an unrestricted, irrevocable, nonexclusive, worldwide right and license to freely use, reproduce, publicly perform and display, prepare derivative works of, transmit, and distribute copies of such submissions for any purpose whatsoever.

I grant Toastmasters the exclusive right to use the Media and grant Toastmasters a non-exclusive right to use my name, likeness, quotations, and/or biographical information ("Name and Likeness") in connection with production, distribution, advertising, and any other Toastmasters' media projects (the "Projects"). The Projects may be edited, composited, changed, reordered, and combined with other works owned by Toastmasters (including use within Pathways Projects) or combined with the works of others either in whole or in part as Toastmasters may determine at its sole discretion without additional compensation of any kind. I grant Toastmasters the exclusive right to use the Media in connection with any portion of its Projects (the "Rights") throughout the universe in all media now or hereafter known, although Toastmasters shall have no obligation to use the Rights as part of the Projects or otherwise. The Rights shall include, without limitation all intellectual property, renewals, and revivals, and the Rights are hereby irrevocably, unconditionally, and perpetually granted.

I acknowledge that the Media taken of me may be used for various purposes, including but not limited to appearing on a club or District website, the Toastmasters website, in the Toastmasters magazine, promotional materials, or any

other media now known or to be invented. I also understand that Toastmasters or any entity authorized by Toastmasters will use images exclusively for Toastmasters-related purposes and not for any commercial gain.

By attending the Event, I waive any right to inspect or approve any photo, video, or audio recording taken by Toastmasters or any person or entity authorized by Toastmasters to do so. I agree that any material, images, suggestions, concepts, and/or other content captured will not be considered confidential or proprietary.

I consent to Toastmasters using any Media that may be sent to Toastmasters by other Event attendees for use in its Projects.

I irrevocably and unconditionally release, waive, and covenant not to sue or otherwise assert any right or remedy (including injunctive or other equitable relief) against Toastmasters, any of its affiliates or related parties, or their respective members, managers, employees, officers, representatives, agents, attorneys, successors, licensees, successors or assigns, for any claim, cause of action, loss, cost, damage, liability or expense of any kind, known or unknown, suspected or unsuspected, (including without limitation based on invasion of privacy, defamation, right of publicity or any other personal and/or property rights), preventing the production, distribution, advertisement or exploitation of the Projects, the Rights, or any production related to or based thereon, rescission or termination of any Projects, the exercise of the Rights, or any act or omission of Toastmasters whether willful, reckless, negligent or otherwise.

Since anyone can download an image from the internet or make copies from printed materials, I agree that Toastmasters is not responsible for unauthorized use of the images. I acknowledge and agree that I am not entitled to any compensation and that the images may appear with or without my name.
