✓ Potential Avoided Emissions

Data on the potential avoided emissions of investments, e.g. companies, infrastructure and Green Bonds.

✓ Portfolio Carbon Footprint Report

Carbon footprint report for equity and fixed income strategies that is designed to support investors who want to comply with key disclosure frameworks, such as the TCFD, Montreal Pledge and others.

✓ Portfolio Climate Impact Report

Climate impact report for equity and fixed income strategies that provides detailed analyses of transitional climate risks covering fossil fuel reserves and renewable energy assets, as well as physical climate risks linked to the sector and geographic exposure of the portfolio holdings.

The report also includes a 2° C climate scenario assessment and is designed to support investors who want to comply with key disclosure frameworks, such as the TCFD, Article 173 of the French Energy Transition Law, PRI and others.

✓ Carbon Risk Rating

The Carbon Risk Rating provides a comprehensive assessment of the carbon-related performance of companies, based on over 100 mainly industry-specific indicators and a carbon risk classification at the industry and sub-industry levels.

The Carbon Performance Score indicates how a company is managing its industry-specific climate risks, not just in production but in its supply chain and product portfolio as well. Our proprietary Carbon Risk Classification categorizes a company's exposure to carbon risk as a result of its business activities.
