Annual Conference Committee on Episcopacy

- The Committee on Episcopacy of an Annual Conference should study and learn the specific responsibilities of the committee as it applies to the bishop, the annual conference, the Jurisdictional Committee on Episcopacy, and The United Methodist Church.
 - ¶637 - Committee on Episcopacy
 - ¶637.1 – AC Committee on Episcopacy – Election and Composition
 - ¶637.2-4 – AC Committee on Episcopacy – Responsibilities

Episcopal Residence Committee

- The provision of housing for effective bishop in the jurisdictional conferences shall be the responsibility of the annual conference or conferences comprising the episcopal area to which the bishop is assigned.

In each episcopal area in the jurisdictional conferences there shall be an episcopal residence committee to provide for this function

- **¶638 – Episcopal Residence Committee**
- **¶638.2– The committee shall be comprised of...**
 - a. The chairperson or designate of the conference committee on episcopacy from each conference
- **¶638.3– The chairperson of the episcopal residence committee shall be the representative of the committee on episcopacy...**
- **¶638.4-5 – Episcopal Residence Committee- Responsibilities**

Jurisdictional Committee on Episcopacy

- The Committee on Episcopacy of the Jurisdictional Conference should study and learn the specific responsibilities of the committee as it applies to the bishop, the annual conference, the Jurisdictional Committee on Episcopacy, the College of Bishops and the Council of Bishops, and The United Methodist Church.
