Event Terms of Use

Participation in Live, Virtual Event

You agree to the following refund policies for events that require payment. Cancellations within 60 days or more will be eligible for a full refund. Cancellations 59 and 30 days of the event, will be subject to a 50% refund. Cancellations within 29 days of the event are not eligible for refunds, however, you may transfer your registration to a colleague, or apply your registration to a future event, less a \$50 administrative fee. Should you cancel your registration outright less than 29 days prior to the event, or do not attend the event, no refunds will be issued.
