WISCONSIN COUNCIL OF CHURCHES PROGRAMS AND PROJECTS

Advocacy ministry informs, educates, equips and mobilizes people to reflect on and address justice issues at the community, state, and national level from a grounding in faith.



Awaken Dane is a cohort-based program funded by Lilly Endowment, Inc. and is focused on building a thriving church in Dane County. The learnings from Awaken Dane will be shared with the church throughout Wisconsin. Pastors lead a congregational team through a 2-year program that involves becoming a people of relationship rather than outcomes • listening without agenda • attending to the stories of people in the neighborhood, and • discerning what the Spirit might be saying to us.

The **Community Health Program** provides faith-based resources to address the COVID pandemic from a perspective of community-wide healing. We organize vaccination clinics and testing sites, provide guidance and useful information related to COVID and vaccination, identify and reduce barriers to vaccination and recommend COVID safety protocols.



The **Community Investment Program** facilitates socially responsible investing by members of the WCC's network, making it possible for individuals, churches and judicatories to contribute financially to the work of building more just communities through local investing.

Education to Action | study-action guides, workshops, consulting, coaching, and guest speakers help churches and groups address critical issues from a faith-based perspective, including hunger • gun violence • interfaith relations • immigration • racial disparities in WI • land acknowledgments • the intersection of clergy & congregational wellness with peace & justice ministry

Racial Justice Coalitions | Faithful Action for a Healthy Wisconsin addresses public health and racial inequity collaboratively with interfaith and secular partners. Taking a Faithful Stand for Racial Equity empowers and mobilizes people to take action for racial equity in their local communities.

Refugee Response ministry takes an ecumenical approach to crisis response, finding solutions to systemic gaps, and offering churches opportunities with ecumenical and interfaith partners to support Afghan refugee resettlement in Wisconsin.



The Wisconsin Interfaith Voter Engagement Campaign (WIVEC) is a nonpartisan initiative educating and mobilizing communities of many faiths in the democratic process. WIVEC is a joint project of the WI Council of Churches and Wisconsin Faith Voices for Justice.
