

2023 NZNO Annual General Meeting (AGM) and Conference Terms and Conditions

PAYMENT TERMS:

- All fees include Goods and Services Tax (GST) of 15% and are in New Zealand Dollars (NZD).
- Registration fees are payable online by VISA or MasterCard, or by direct credit.
- Registrations are not fully confirmed until payment has been received.
- Payment by invoice is required within 14 days from the date of registration or before **1 August 2023**, whichever date is the earliest.

PRIVACY AND EMAIL POLICY

New Zealand Nurses Organisation Inc (hereafter referred to as NZNO), does not collect any personal information from your computer or mobile device while you are browsing its website. However, site usage data can be obtained, because the site uses Google Analytics, but it will not result in you, as a user, being identified by us.

EVENT REGISTRANTS

The information requested by the registration process is for use by the NZNO to facilitate this event. Registration data is retained by us for the collection of statistics and for the general purposes set out below.

USE OF INFORMATION GENERALLY

All information we hold may also be used by NZNO for:

- the technical operation, maintenance, administration, and support of the event registration process
- otherwise supporting you, reporting upon, improving, and planning our event services
- you may opt out of receiving event communications from NZNO at any time by contacting the Event Organiser below. By doing so, you will no longer receive important information relating to registration updates, such as a change to flight or accommodation bookings.

CONDITIONS OF ATTENDANCE

- **Wednesday, 20 September 2023 - NZNO Annual General Meeting**
Members attending the NZNO AGM must be authorised representatives of regions, sections, colleges, and membership groups as per NZNO Constitution *Clause 27*.
All other NZNO members who wish to attend the AGM but are not eligible as per *Clause 27* above, may do so; however, these members will not be eligible for travel and accommodation subsidies and shall have no vote.
- **Wednesday, 20 September 2023 - Conference Dinner**
Authorised representatives attending the NZNO AGM are not required to attend the conference dinner; however, may attend if they wish at no additional charge.
- **Wednesday, 20 September 2023 - National Student Unit (NSU) AGM**
This meeting is restricted to NSU members, who must also attend the NZNO AGM to benefit from subsidised travel and accommodation.

➤ **Thursday, 21 September 2023 - NZNO Conference**

Authorised representatives attending the NZNO AGM are not required to attend the conference; however, may attend if they wish at no additional charge.

A fee applies for both NZNO members and non-members attending the Conference Day only. Attendance under this category is not eligible to subsidised travel or accommodation.

➤ **Accommodation** is subsidised for authorised representatives (refer above conditions) under the following registration categories:

- NZNO AGM, NSU AGM, Conference Day.
- If you are attending the AGM **only** and are required to fly from Queenstown or live more than one hour's drive from **Dunedin Airport**, you will be flown to Wellington the night before and provided with accommodation.
- If you live less than 80km to the Wellington CBD, you are **not entitled to accommodation**. You are, however, entitled to travel cost reimbursement upon providing a full GST invoice/receipt. NZNO will reimburse the most cost-effective method of travel ie by public transport.
- If you live more than 80km from the Wellington CBD, you are **entitled to accommodation**. NZNO will also reimburse the most cost-effective method of travel eg km or by public transport.

CANCELLATION AND REFUND POLICY

- Minimum and maximum numbers apply.
- Registrations will be accepted on a first come/first serve basis (**provided payment has been received if applicable**).
- NZNO organises and pays for flights for authorised representatives. Once flights have been confirmed (ticketed), any changes may be made directly with NZNO travel provider (Tandem Travel), and any change fees and/or fare differences will be the **responsibility of the traveller**. Tandem Travel will require payment before any changes are made.
- NZNO reserves the right to on-charge any loss incurred due to cancelling your registration after **5.00pm 1 August 2023**. **All cancellations must be notified in writing to the Conference Organiser, by emailing conference@nzno.org.nz**
