HISTORY OF NJEPA



The New Jersey Emergency Preparedness Conference had its humble beginnings as a "grass roots" organization. It started as a conversation at Atlantic County OEM looking for a way to provide higher level training and experiences to local emergency managers. County and State personnel had the opportunity, back then, to attend state, regional and national conferences and the Atlantic County and South Region OEM teams were brain storming ways to bring this kind of information to local EMCs and their teams at no cost. With the tremendous support of the Tropicana Casino Resort and Verizon the Atlantic County Hurricane Seminar was born.

This first effort presented eight speakers on various topics related to coastal preparedness issues for hurricanes. The one day seminar was well received by the approximately 200 people in attendance and they requested expanding the program for the following year. In 2000 we expanded to a 2 day seminar adding a larger program of speakers which required us to recruit more sponsors to fund the popular program which was presented at no charge to attendees. Expanding the conference would present a number of challenges including increased participation by our host the Tropicana Hotel Casino and the Atlantic County OEM, NJ State Police OEM, sponsors Verizon, State Farm and those behind the scenes people that made the simple seminar a huge success. Several of the local, county, and state emergency management officials had attended the very popular National Hurricane Conference for many years. A small group of them wanted to try and create a conference similar but unlike our friends at the NHC.

The 2001 NJ Hurricane Preparedness Conference would be different. It would feature 18 one hour breakout sessions, 2 continental breakfast, 2 sponsored lunches, and an exhibit area for 2 days with 32 exhibitors. This was a logistical and financial nightmare tackled by a handful of very dedicated emergency preparedness professionals. Due to unwavering dedication of a select group of people using creative and out of the box solutions the nearly \$60,000 conference came off very successfully with over 600 attendees. At the after conference meeting the small group decided that we needed to invest the time and effort to continue our successes by forming the New Jersey Emergency Preparedness Association. This required a strong commitment and backing of our sponsors and partners who were behind us all the way and one current event in world history would be the rocket fuel to the creation of the New Jersey Emergency Preparedness Association and the New Jersey Emergency Preparedness Conference. That date: September 11, 2001.

The conference continues today, 25 years later at our new home the Hard Rock Hotel & Casino; tens of thousands of attendees and thousands of sponsors have made this program the success that it is.

RECEPTION SPEAKER



COLONEL PATRICK J. CALLAHAN NEW JERSEY STATE POLICE

"Colonel Patrick J. Callahan was sworn in on October 31, 2017, as the 14th Colonel of the New Jersey State Police. He is in his 30th year of service with the New Jersey State Police, serves as the State Director of the Office of Emergency Management, and serves as a member of the New Jersey Coro-

navirus Task Force established by Governor Murphy in February of 2020. He previously served as the Deputy Superintendent of Operations overseeing nearly 1,800 road troopers assigned to State Police stations throughout the State.

Prior to this assignment, Colonel Callahan served as the Deputy Superintendent of Administration. Previous assignments also included him serving as the Commanding Officer of the Emergency Management Section, as well as the Recovery Bureau Chief in the wake of Super Storm Sandy. In this role, he was responsible for working with FEMA, all State Departments, county, and local government entities, as well as the Governor's Office of Recovery and Rebuilding to administer and oversee the \$1.5 billion in FEMA Public Assistance and Hazard Mitigation funding awarded to the State.

Colonel Callahan has also served as the Chief Financial Officer for the New Jersey State Police and has held various assignments in the Administration Section overseeing budget and fiscal responsibilities associated with the Division. He was also assigned to the Homeland Security Branch and assisted in the planning and distribution of the federal homeland security funding awarded to the State and its 21 counties in the wake of 9/11. Prior to this assignment, Colonel Callahan served as a station detective and general road duty Trooper.

Colonel Callahan earned a Master's Degree in Administrative Science from Fairleigh Dickinson University and earned his Bachelor of Arts Degree from Villanova University. He is a graduate of the 243rd FBI National Academy Session where he was elected Session President. Colonel Callahan also served as the Chairman of the State Police Retirement System Pension Board of Trustees until his recent appointment to Colonel on November 1, 2017.

He has been married to his high school sweetheart Linda for 34 years and they have four children and three grandchildren."







NJ EMERGENCY MANAGER'S MEMORIAL SCHOLARSHIP PROGRAM



Jonathan Cardell William Young was born for a lifetime of service. He began the journey November 28, 1961, in Newark, New Jersey, son of Ruth Griffin Young and Howard Curtis Young. In 1979, he graduated from Abraham Clark

High School in Roselle and from Linden Vocational Technical School where he studied electronics.

At age 15, Jon started his career in emergency services with the Roselle Volunteer Ambulance Corps. In 1979, he became a volunteer firefighter for the Roselle Fire Department, and in 1990, he achieved his life goal to become a career firefighter for the department. In 2001, he was promoted to lieutenant; he later earned the rank of captain. He was a certified Level 2 Fire Department Training Officer, training firefighters at the Roselle Fire Department and at the Union County Fire Academy. He served as an EMT for over 23 years and as coordinator of the Office of Emergency Management in Roselle.

Jon was Roselle's most highly decorated firefighter. In addition to being awarded Fire Fighter of the Year three times, he received Valor Awards from the New Jersey Fireman's Mutual Benevolent Association and the St. Barnabas Hospital Burn Foundation, and the Community Service Award from the Roselle NAACP. A highlight of his career was the delivery of thirteen babies. In 1997, while off duty, Jon rescued a civilian trapped in a burning car, for which he received a Valor Award from the City of Woodbridge.

In his memory, and in an effort to preserve his love for the community, the Borough of Roselle, the Roselle Chamber of Commerce, Agape House of Worship, and the Young family are holding the Annual Jon Young Memorial 5K. Jonathan was a certified HAZMAT specialist and communications specialist with the New Jersey Urban Search and Rescue Team NJ-TFI. NJ-TFI was the first rescue team at Ground Zero on September 11, 2001, and remained there for ten straight days.

Following that assignment, he worked with the University of Medicine and Dentistry of New Jersey in a mental health support program for first responders. Jon was the communications officer for the NJ Task Force and president of the NJ Emergency Preparedness Association.

He was a certified instructor for confined space rescue, high angle rope rescue, HAZMAT, automobile extrication, CPR, weapons of mass destruction, blood borne pathogens, incident command systems, and emergency vehicle driving. In his off time 'Juice,' as he was affectionately known, enjoyed spending time with family and friends. He was a licensed Ham Radio Operator and was in the process of obtaining a pilot's license. He loved all animals, especially Kieko and Kayla, his beloved Labradors. Jonathan C. W. Young departed this life in the line of duty on November 16, 2011, just shy of his 50th birthday. 'Well done, my good and faithful servant.'





NJ EMERGENCY MANAGER'S MEMORIAL SCHOLARSHIP PROGRAM



Michael Walter Augustyniak, known to almost everyone as "Augie," began his career with the New Jersey State Police (NJSP), and became a true expert in the field of Emergency Management. In his more than 33 years

there, he developed policies and procedures still in effect today, and trained countless others in their implementation. Mike was an esteemed and beloved colleague and friend to many.

He accomplished much in his long tenure with the NJSP, playing important and lasting roles in many assignments. He worked in the Emergency Response Bureau and was the Emergency Management Section's hazardous materials (HAZMAT) expert. As an instructor, he developed and conducted exercises, provided technical assistance visits and, over a period of five years, almost single-handedly brought the HAZMAT annexes of the State's 566 municipalities and 21 counties up to the standards demanded by the Federal Emergency Management Agency (FEMA). Later, when the Section reorganized, Mike moved to the Operational Planning Bureau and served as a Shift Chief when the State Emergency Operations Center was activated. Mike soon became the Section's, and indeed several governors', go-to-guy in weather situations during hurricane season.

He was instrumental in developing plans for the State's new fusion center, the Regional Operations Intelligence Center, and was a stalwart during the Y2K transition and numerous major federal exercises. Mike also contributed his talents for several years to the Emergency Management Accreditation Program (EMAP), traveling nationally and internationally to assess jurisdictions for accreditation, and playing a key role in the NJSP's initial accreditation and re-accreditation.

Mike was a deeply thoughtful and intellectual professional. He cared earnestly about the mission and always saw the potential of the organization and strived untiringly to help everyone achieve it. His knowledge of the capabilities and limitations of state agencies was unsurpassed. He was unquestionably one of the most respected and versatile civilian employees in New Jersey State Government.

After he retired, Mike continued to use his emergency management and planning skills as a contractor, coordinating and developing policies for New Jersey Task Force 1, one of 28 FEMA Urban Search and Rescue Teams. He assisted NJTF1 in gaining EMAP accreditation, and ensured its policies and procedures met the benchmarks required to conform to FEMA Administrative Readiness guidelines. Mike also co-taught several classes at the Emergency Management Institute in Emmitsburg, Maryland. And for a change of pace, he worked several hours a week at the tiny and beloved Crosswicks Library in Crosswicks, New Jersey, a mile from his home, and served as primary editor for his father's book, Adventures of a Young Marine in WWII, published in 2018.

Mike was the best husband, father, brother, son, and friend anyone could ask for. He will be remembered most for his sense of humor and infectious laugh, his thoughtful and loving nature, his cleverness and curiosity, and his incredible zest for life.

In the words of his beloved Star Trek, may he "live long and prosper!"





TUNO EMERGENCY MANAGER OF THE YEAR



Kevin H. Tuno was the Burlington County Emergency Management Coordinator for 17 years, culminating a career with Burlington County that began as an emergency services dispatcher in 1982. Kevin was also a former chief of the Burlington City Fire Department, a life member of the Young America

Fire Co., and Endeavor Emergency Squad, and a member of the Independent Fire Company, all in Burlington. He was also a member of the New Jersey Emergency Preparedness Association.

At his passing, Burlington County Freeholder Director Mary Ann O'Brien said, "The entire Burlington County community is deeply saddened by the passing of our longtime emergency management coordinator Kevin Tuno. Kevin led the county's response during trying times, including through the Sept. 11 terrorist attacks, the devastating July 2004 flood, and Superstorm Sandy."

Kevin had over 30 years of experience in emergency management and disaster response. As the emergency management coordinator, Kevin was instrumental in the formation of the Burlington County Community Emergency Response Teams (CERT). Kevin received a Master's Degree in Administrative Science, the Certified Public Manager designation from the state of New Jersey, he was a master exe cise practitioner and an Adjunct Professor at Burlington County College.

Barry E. Eck, President of the New Jersey Emergency Management Association, said in a statement: "Kevin was a talented and dedicated emergency management coordinator who loved his work. His experience and wisdom provided foresight with balance to the otherwise chaotic world of emergency management." Kevin Tuno died at age 56 on Sept. 15, 2015, at his residence in Burlington City.

8:00 - 17:00 / ArcGIS Online - Essential Workflows / Studio 2B

This course introduces web maps, apps, and other authoritative content that may be available through your ArcGIS Online organizational site. You will learn how to discover, use, create, and share content that infuses projects with geographic context, additional business intelligence, and visual impact. All NJ County OEMs are provided ArcGIS Online licensing by the New Jersey Office of Emergency Management for use in disaster resilience, situational awareness, damage assessment, debris management, information sharing, as well as other public safety workflows.

8:00 – 17:00 / AWR-219: Site Protection through Observational Techniques (SPOT) / Hollywood East This course trains public safety personnel to improve their observational techniques by using a 4-step ongoing screening process that includes increasing protective awareness, identifying preoperational behaviors, evaluating, and taking action. Participants will learn ways to increase their personal situational awareness and observation skills. Participants will be introduced to common behaviors and objects that are associated with preoperational terrorism activities. Finally, participants will engage in a collaborative learning activity that uses fictional scenarios to test the objectives from the previous modules.

8:00 - 17:00 / AWR-326: Tornado Awareness / Big Cypress Studio B

Tornadoes can strike anywhere in the United States with little or no warning. It is important that every community be prepared by understanding tornadoes and the associated dangers. This course will prepare participants to understand the basics of tornado science, the weather forecasting process, the tornado warning process, and the fundamentals of tornado safety and preparedness. Multiple core capabilities will be addressed, with particular emphasis on "public information and warning" and "threats and hazard identification. Participants will be better able to implement safety measures for themselves, their families and their organizations in preparation for tornado season.

8:00 - 12:00 / Basic and Advanced Skywarn Training / Immokalee A

SKYWARN is a volunteer program of storm spotters who relay real-time weather information to the National Weather Service (NWS). The NWS is responsible for issuing severe weather warnings that alert people when a potential threat will affect their area. Incorporating real-time reports from storm spotters makes the warnings more accurate, credible, and timely. Spotter reports are also used to verify if severe weather is occurring or did occur during the official warning. This training will also include a return of the Advanced SKYWARN spotter talk, which will cover more complex techniques on observing and identifying severe weather.

8:00 - 17:00 / G0108 - Community Mass Care and Emergency Assistance (Day 1 of 2) / Immokalee B This course provides training for local communities to prepare for and manage the Mass Care/Emergency Assistance (MC/EA) functions effectively. The goal is to prepare community agencies, organizations, and businesses to work together in coordination with Emergency Management and traditional MC providers to plan and provide MC/EA services to those affected by disaster. G0108 is a required course for the Advanced Professional Series (APS) certificate.

ADVANCED PROFESSIONAL DEVELOPMENT SERIES CLASSES

NJEPA in partnership with the New Jersey State Police Office of Emergency Management is pleased to continue the initiative that will allow Conference attendees to complete the Advanced Professional Series within three years.

The Advanced Professional Development Series offers "how to" training focused on practical information. This series emphasizes applied skills in disaster operations and management, in conjunction with the Professional Development Series emergency management fundamental skills. The series completion certificate is a standard that is recognized across the country. The APS does not require a recertification once initially completed and there is no cost to participate in the FEMA sponsored certification program. APS courses are delivered through the New Jersey OEM.



The National Weather Service is undergoing a transformation in the delivery of water information to the public, scheduled for implementation in the spring of 2024. The existing Advanced Hydrologic Prediction Service (AHPS) webpage will be retired, and replaced with the more advanced, user-friendly National Water Prediction Service (NWPS), hosted on ArcGIS Online. This training session will feature a live demonstration showcasing the capabilities and services offered by NWPS.

9:00 - 10:15 / The role of an Incident Management Team at local events / Big Cypress Studio B Members of the NJ-AHIMT and OEM County coordinators will provide an update on the release of NJOEM Directive-10 (2022), the use of the Incident Command System, Administration of the NJ All-Hazards Incident Management Team, and the Incident Management Team Credentialing process. The team will also discuss the use of the NJ-AHIMT at the severe weather event in Warren County and the HazMat incident in Gloucester County.

9:00 - 10:15 / We've got an EOP for Hospital Decon, Now What? / Fort Pierce C

Decontamination is a big word, and can be overwhelming to the uninitiated. This program will explore the operationalization of a robust hospital-based decontamination program. We will discuss how we empowered frontline staff to "own" the education and monthly trainings and exercises. Additionally, we'll discuss how we engaged with key stakeholders and members of the multidisciplinary team, and added strategies for the AFN population in a decontamination setting.

10:30 – 11:45 / Bombing Prevention Awareness Course presented by NJSP Bomb Unit / Fort Pierce B The presentation is based from the Office of Bombing Prevention "The course is the Bombing Prevention Awareness Course (AWR-348)". It provides an introduction to the terrorist attack cycle, an overview of IEDs, homemade explosives, and a response to suspicious behaviors and items. This basic awareness is used to enhance bombing prevention measures. This course will cover the following topics: IED construction and classification, IED explosive effects, HME and precursor awareness, the terrorist attack cycle, response to suspicious behaviors and items.

10:30 – 11:45 / Emergency Planning and Community Right-to-Know Act (EPCRA) / Immokalee B The Emergency Planning and Community Right-to-Know Act of 1986 was authorized by Title III of the Superfund Amendments and Reauthorization Act to help communities plan for chemical emergencies. It requires industry to report on the storage, use, and releases of certain chemicals to federal, state, tribal, territorial, and/or local governments. It also requires these reports to be used to prepare for and protect their communities from potential risks. LTC. DeMaise and Bob Van Fossen presenting on the topic of EPCRA and providing Q&A session.

10:30 – 11:45 / Energy, Water and Data? The Natural Hazard and Cybersecurity Threat Nexus / Fort Pierce C In 2023, the FEMA Administrator remarked that what kept her up at night was the looming dangers of cyber and disinformation campaigns by nation-state actors. With the increasing frequency and severity of extreme weather events, the security of critical infrastructure has never been more highly interconnected and vulnerable to natural hazards. We are at special risk of cyber attacks during these natural disasters. This session will discuss why data infrastructure is considered as important as energy and water. It will provide examples of cyber and disinformation campaigns during disasters and how communities can best prepare for these threats.

10:30 – 11:45 / Review of the NWS Air Quality Program: The Great June 2023 NJ Smoke Event / Immokalee A The National Weather Service (NWS), in partnership with the Environmental Protection Agency (EPA) and State Air Quality entities, relays daily air quality forecasts in the form of an Air Quality Index (AQI) and an Air Quality Alert (AQA) when air quality conditions become hazardous to human health. In early June 2023, the combination of an unusually active fire season across eastern Canada and a blocking upper level weather pattern resulted in a multi day "smoke" event across NJ. The resulting smoke episode reduced visibilities at the surface for several days, peaking on Wednesday, June 7th, 2023.

13:00 - 17:00 / Active Shooter Incident Management (ASIM) - Basic #1 / Hollywood East
The Active Shooter Incident Management (ASIM) Basic course is a 4-hour performance-level training designed to improve incident management and coordination among law enforcement, emergency management, and fire and EMS responders during active shooter events. The course provides a validated framework for school personnel, law enforcement, fire, and EMS to effectively manage violent event responses, with a specific emphasis on minimizing response time, providing timely medical intervention, and enhancing victim survivability. Our greatest obstacle to effective incident management, however, is overreliance on ICS. ICS is not the solution to incident management – it's a tool. For incident management to be truly effective, we need to think beyond ICS.

14:30 - 15:45 / NJOEM - Emergency Management Reservist Program / Big Cypress Studio B
In April 2023, NJOEM established its first ever Emergency Management Reservist Program (EMRP).

G0557 is a required course for the Advanced Professional Series (APS) certificate.

This course is intended to promote the effectiveness of incident operations by standardizing the incident action planning (IAP) process. The IAP process requires the completion of nine primary ICS forms with the option of additional forms to be utilized as needed. The course will demonstrate how to complete the ICS forms and develop an IAP. The student will also work through a scenario completing ICS forms and developing an IAP. The course will also discuss tools available to assist in the development of an IAP.

9:00 - 10:15 / Domestic Violence and Natural Disasters How Do We Better Plan? / Fort Pierce B Domestic violence is willful intimidation, physical or sexual assault, and/or other abusive behavior as part of a systematic pattern of power and control perpetrated by one intimate partner against another. It includes economic deprivation, threats, and emotional abuse. The frequency and severity of domestic violence can vary dramatically. During times of disaster, incidents of DV increase, including in disaster sheltering, something we need to consider during the planning stages or preparing for an event. This class will help you learn signs and resources available, especially as it impacts residents we may be trying to help during a disaster sheltering event.

School based threat assessment teams provide school staff with assistance in identifying students of concern, assessing those students' risk for engaging in violence or other harmful activities, and delivering intervention strategies to manage the risk of harm for student(s). School based threat assessment teams are to include police representation for certain circumstances. In this session, the NJ Department of Education will share an overview of the teams and operations.

10:30 – 11:45 / After Care for Healthcare Providers Post Active Shooter Incident / Fort Pierce D
In today's turbulent world, healthcare providers are often thrust into high-stress situations, including active shooter incidents. About 15% of the nation's public-school population have students with physical, behavioral or sensory disabilities. In New Jersey, there are 241,000 K-12 students with exceptionalities and have needs, which must be addressed in a school crisis. The student's special needs must be considered in school security plans and shared with first responders when assisting this student population. In this session, content will be shared on how first responders may collaborate with school district personnel. to assist students with special needs.

10:30 – 11:45 / Tri-State Canine Response Team: Local roots – global impact! / Big Cypress Studio B Dogs have a way of de-stressing humans without trying. Pair that with trained responders and you will understand what Tri-State Canine Response Team has been doing since 2015. Tri-State began as a small, therapy dog group aimed at providing comfort and support to our community, especially our first responders. Over 8 years, this all-volunteer group has grown to include nearly 100 teams in 7 states, provided national support during 17 mass incidents, responded hundreds of times to local incidents and most recently expanded internationally. This presentation will provide insight into our unique approach and why our teams are effective.

13:00 – 14:15 / Anticipating the Disaster Behavioral Health Challenges of Climate Change / Fort Pierce D Climate change-fueled disasters impact individual behavioral health and include trauma and shock, PTSD, anxiety, and depression that can lead to suicidal ideation and risky behavior, feelings of abandonment, and decreased physical health. This overview will introduce the five domains of behavioral health impacts related to climate change, along with discussion of the concepts as they apply to emergency planning and policy. Anyone involved in the preparedness for, response to, or recovery from disasters must begin to develop an understanding of the impact of climate change and its effects on human behavior and behavioral health.

13:00 - 14:15 / Introduction to the New Jersey Fire Threat Task Force / Immokalee B

The Introduction to the New Jersey Fire Threat Task Force is a presentation on the purpose of the task force. 
