# Safe working in the COVID -19 pandemic

**May 2020**: BSI developed the <u>Safe Working Guidelines</u> as a free resource Written with input from broad range of experts and regular public consultation -3 iterations in 3 months

July 2020: Submitted to ISO to be developed as a global document

September 2020: Developed as an ISO PAS (publicly available specification)

Consensus achieved in 2 weeks with experts from 31 countries and 3 international liaison organizations

**November 2020**: Approved by ballot of the 100 countries in the technical committee

### December 2020: Published



## ISO PAS 45005

- A generic document, suitable for any organization regardless of size, location or type
- Developed to reflect good practice from trusted sources across the world
- Plans to review and update if necessary, as knowledge grows and the situation changes



# Comprehensive, practical recommendations for any organization

- Identifying and managing COVID-19 risk in all types of work settings

- Adjusting where, how and when you work – for individuals and as a whole

- Consulting with workers for the best possible outcomes

- Recognizing the importance of well-being and psychological health

- Managing outbreaks in workplaces and in mobile or home workers
- Dealing with contact tracing, testing and quarantine
- Responding effectively to sudden changes in restrictions or rules
- Managing hygiene and effective use of face coverings and PPE
- Communicating, monitoring and improving how you manage risks

## Managing OH&S in times of crisis – key points

- Plan for foreseeable crises
- Build agility into your management systems & resilience into operations
- Be prepared to be flexible
- Take into account the foundational importance of psychological health
- Clear, regular communication is essential
- Consult workers and worker representatives to ensure you have buy-in
- Don't forget existing OH&S risks: changes can create new risks or compromise existing safety measures
