



# **Exhibit Application**

All applicants for exhibit space are required to complete the application for exhibit space contract online. Completion of the application indicates the applicant's willingness to abide by all contract terms, conditions and all rules, regulations and general information listed in the online application, terms and conditions document and exhibitor manual. This application, with full contract conditions, is available at **Exhibitor Information**.

All exhibitors will be required to submit the following information during the online application:

- A short 50-word company/booth description for your exhibitor listing, in both languages if possible
- Your company logo and website
- A contact name and email address which can be published with you exhibitor listing
- A name and email for each individual booth attendant to be registered (names can be changed after submission)

Exhibitors are required to maintain qualified staff in their booth at all times during the exhibit hours

#### **Eligibility rules**

All companies, products and services exhibited must be directly related to the practice and advancement of pediatrics and the education of conference delegates. The CPS has the right to reject any applications that do not further the education, scientific, or practice needs of its members and attendees.

#### **Terms of Payment**

Full payment is required upon a completed application for booth space. CPS accepts payment by VISA or MasterCard. Space cannot be held without a completed application form and FULL payment. Those wishing to pay by cheque must submit payment to CPS prior to selecting their booth online.

#### **Cancellation and Refund Policy**

Cancellation requests must be submitted in writing to the CPS. Cancellations received **prior to April 1, 2024**, will receive a full refund of exhibit fees paid, less a 25% administration fee. Contracts cancelled between **April 1, 2024**, and **May 1, 2024**, will be refunded one-third of the total exhibit fees paid. However, if the space is not resold then CPS will retain 100%. No refunds will be given on cancellations received after **May 1, 2024**.
