#### CREDENTIALING

Credentialing services centrally manage practitioner/clinician data, the provider application, professional references and primary source verifications for efficient evaluation and privileging. Once a digital provider profile is created, organizational policies are applied to render a comprehensive application for review. In addition, integrated platform tools enable a broader view of provider performance to support an appointment decision including, Patient Relations, Event Management, and Peer Review.

Separate departments within a healthcare organization typically perform enrollment and credentialing functions that certify practitioners. Beyond duplicating work, this can lead to significant liability and impose a negative impact on reimbursement. A robust tool leverages the entirety of the verified practitioner dataset, managed by Verge Health's credentialing services, for any relationship type (payer, hospital, or licensing agency).
